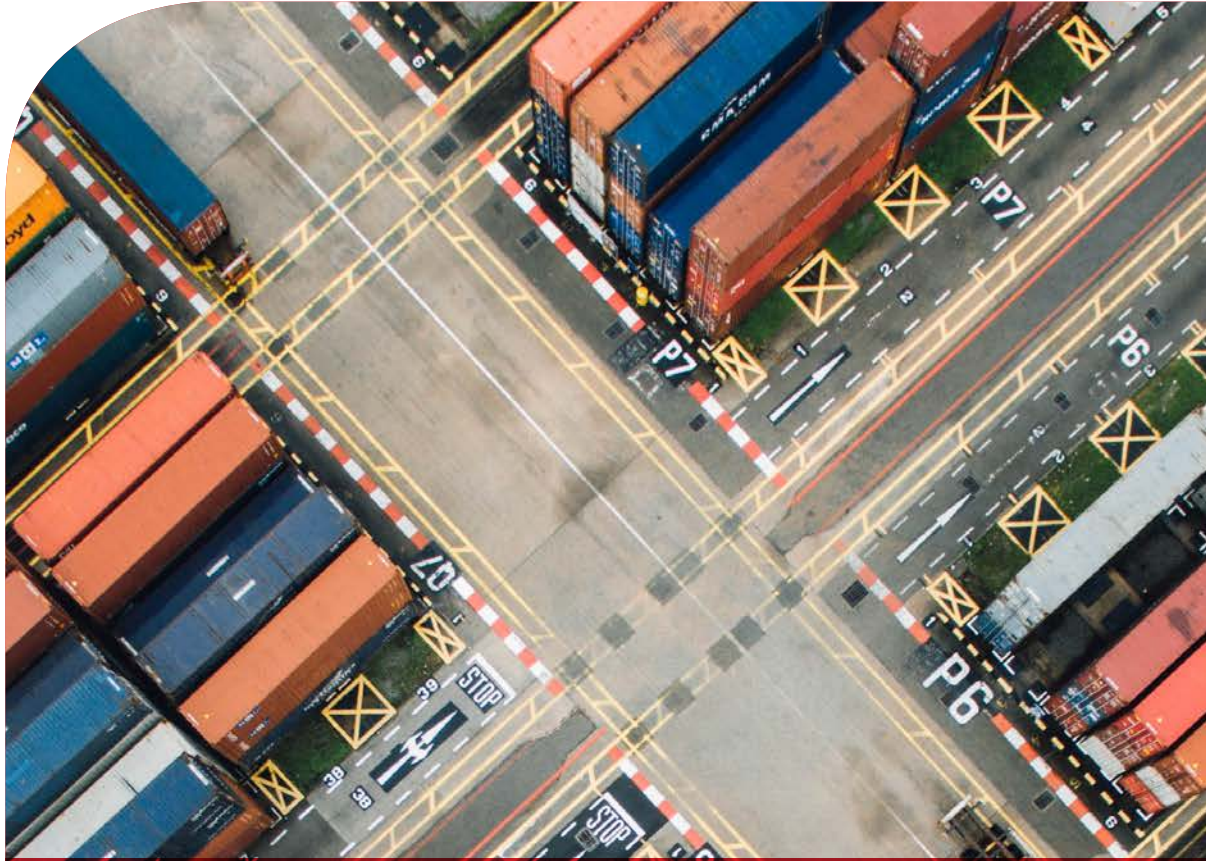

Import Clearance Of Goods

This is when a client from the local community buys any kind of goods from other countries bringing it into Zambia. It has to pass through customs for clearance for verification and tax purposes; hence the client needs to present the export document to Frontways.

Therefore Frontways will do the declaration according to the export documents, of which the tax payment will be required just after the declaration by us.

Customs will review the export documents to verify whether the declared goods are true and correct. If all is correct, the release order document will be issued and the goods released

Export Clearance Of Goods

This is the type of declaration made whenever the goods are being exported from one country to another and customs taxes and verification will be required if all is well the release order will be issued and the goods will be released.



Removal In Transit (RIT)

This is the kind of declaration where the goods are just passing through the country going to the final destination country, goods will have to go under customs verification and are being monitored from port of entry up to the port of exit. Usually the truck or vessel carrying the goods is given 5 days to exit the country.



Customs Import Permits (CIP)

This is a permit given to a foreigner who comes with a car for a temporal visit and is only valid for 6 months.



Temporal Import Permit (TIP)

This is a permit given to a client who is importing a vehicle or other goods just for work purposes up to a given period of time, there after the goods must be returned. Mostly the permit is valid for up to one year but can be extended.

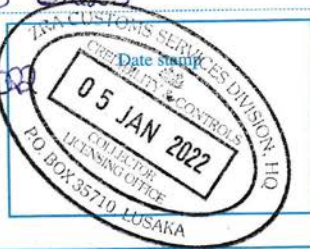
